- · Do Not Use A Hybrid Wash

#### **Manual Washing**

- · Don't wash in direct sunlight
- · Don't wax or polish the coating
- Don't use abrasive wash or drying towels



## THE CURING PROCESS

THE TOTAL CURING TIME FOR JADETM CERAMIC COATINGS IS 2 TO 3 WEEKS. THIS DEPENDS ON THE ENVIRONMENTAL CONDITIONS WHERE YOU LIVE. HUMIDITY AND TEMPERATURE DO PLAY A ROLE IN THE CURING TIME PERIOD DURING THE CURING STAGE YOU SHOULD AVOID THE FOLLOWING ELEMENTS:

WATER: FROM WEATHER AND INCLUDING NEARBY SPRINKLERS. JADE™ CERAMIC COATINGS WILL PROTECT YOUR VEHICLES CLEAR COAT FROM WATER SPOTTING, HOWEVER DURING THE CURING PROCESS EXPOSING YOUR FRESHLY COATED VEHICLE TO WATER CAN CAUSE HARD WATER SPOTS TO BE VISIBLE.

TREES: PLEASE BE AWARE THAT PARKING UNDER A TREE OR A PLANT THAT CAN RELEASE SAP OR POLLEN COULD CAUSE DAMAGE TO THE COATING.

ANIMALS: BIRD DROPPINGS LEFT ON THE JADETM CERAMIC COATING WILL CAUSE SPOTTING AND STAINING DURING THE CURING PROCESS.

KEEP IN MIND THAT THE COATING IS CURRENTLY SOFT AND IF YOU NOTICE THE VEHICLE FINISH HAS WATER SPOTS, BIRD DROPPINGS, TREE SAP OR POLLEN ETC. REMOVE THOSE CONTAMINANTS OFF USING THE CAR CARE INSTRUCTIONS. OR CONTACT A JADE™ CERAMIC CERTIFIED INSTALLER FOR INSTRUCTIONS.

## WASHING YOUR VEHICLE AT HOME

JADE™ CERAMIC COATINGS ARE EXTREMELY HYDROPHOBIC; THIS MEANS THINGS LIKE DIRT WILL NOT STICK TO THE SURFACE OF THE COATING. THIS IS DUE TO THE SELF CLEANING PROPERTIES OF THE COATINGS. BIRD DROPPINGS, BUGS, AND TREE SAP CAN BE REMOVED USING A DAMP MICROFIBER TOWEL, PANEL WIPE OR SOLVENT.

## WASHING

- JADE™ RECOMMENDS YOU WASH THE VEHICLE ON A BIWEEKLY BASIS TO AVOID EXCESSIVE CONTAMINATION BUILDUP, YOU WANT TO USE A PH NEUTRAL SOAP, OR A SILICA INFUSED SOAP.
- AVOID USING A BRUSH TO WASH THE CAR OR A HIGH VOLUME CAR WASH WITH ROTATIONAL BRUSHES AVOID HIGH PH DETERGENT SOAPS AND CLEANERS.
- 3. AVOID WASHING THE CAR IN SUNLIGHT TO MINIMIZE STREAKING.
- 4. WASHED THE VEHICLE FROM THE TOP DOWN. IT WOULD BE BEST TO USE A FOAM CANNON FILLED WITH JADE™ DETOX WASH SOAP TO HELP WITH THIS PROCESS.
- ENSURE THAT YOU'RE USING DIFFERENT WASH MITTS AND TOWELS FOR CLEANING WHEELS. THIS
  PREVENTS CROSS CONTAMINATION WHICH COULD CAUSE DAMAGE TO THE COATING.



## METHODS OF WASHING

- AT HOMÉ WASH: USE A FOAM CANNON OR A MICROFIBER WASH MITT TO SOAP DOWN THE CAR. RINSE THE SOAP OFF AND DRY THE VEHICLE WITH A 400 GSM MICROFIBER TOWEL OR AN AIR DRYER.
- 2. SELF CAR WASHES: SOAP DOWN THE CAR BY SELECTING THE HIGH PRESSURE SOAP OPTION. THEN RINSE OFF THE SOAP WITH THE HIGH PRESSURE RINSE. DRY WITH A 400 GSM MICROFIBER TOWEL.
- 3. HIGH VOLUME CAR WASHES: ONLY USE A TOUCHLESS CAR WASH AND NEVER USE A BRUSH CAR WASH. DO NOT USE THE "HOT WAX" OR "SPRAY WAX" OPTION.

## DRYING

- I. DO NOT ALLOW YOUR VEHICLE TO AIR DRY OR LEAVE HARD WATER STANDING ON THE SURFACE. THE TAP WATER IN MOST HOUSEHOLDS AND IN SOME CAR WASH BUSINESSES HAS HARD WATER OR A MINERAL CONTAINED WITHIN THE WATER THAT MAY LEAD TO DEPOSITS CREATING WATER SPOTS. YOU CAN REMOVE THIS WITH A WATER SPOT REMOVER. ASK YOUR CERTIFIED JADE™ CERAMIC COATING INSTALLER FOR MORE DETAILS.
- 2. JADE™ SUGGESTS ONLY USING HIGH QUALITY MICROFIBER TOWELS TO DRY YOUR VEHICLE OFF BY WIPING DOWN THE FINISH OF THE VEHICLE. USE LIGHT PRESSURE. NEVER AGGRESSIVELY WIPE YOUR COATING.

## SPOT REMOVAL

- I. CONTACT YOUR INSTALLER FOR SPOT REMOVAL. NEVER USE AGGRESSIVE COMPOUNDS OR POLISHES TO REMOVE CONTAMINATION FOR THE JADE™ CERAMIC COATINGS.
- DO NOT USE AGGRESSIVE FORCE TO REMOVE WATER SPOTS FROM THE COATING. CONTACT A CERTIFIED
  JADE™ CERAMIC COATING INSTALLER.
- 3. BIRD DROPPINGS, TAR, TREE SAP AND OTHER CONTAMINANTS SHOULD BE REMOVED AS SOON AS POSSIBLE TO AVOID DAMAGE TO THE CERAMIC COATING.

## AFTER WASHING

DO NOT USE WAX ON THE JADE™ CERAMIC COATING. IT WILL NOT BOND APPROPRIATELY TO THE COATING. YOU SHOULD ONLY USE CERTIFIED PRODUCTS ON THE VEHICLES COATING. ASK YOU CERTIFIED JADE™ CERAMIC INSTALLER ABOUT PURCHASING JADE™ CAR CARE PRODUCTS. OR VISIT WWW,JADE-CERAMIC.COM

## **AUTOMATED WASHING**

ALWAYS GO TO A TOUCHLESS CAR WASH, NEVER USE A HIGH VOLUME CAR WASH WITH BRUSHES. THIS WILL VOID THE WARRANTY ANDDULL THE COATING. JADe™ GRAPHENE, QUARTZ, GRAPHENE PRIME, ICE AND GRAPHING PRO TAKE ABOUT TWO TO THREE WEEKS TO ACHIEVE A FULL HARDNESS. PLEASE MANAGE THE COATING WITH CARE AND DO NOT WASH THE VEHICLE FOR THE FIRST TWO WEEKS.

## LEATHER AND FABRIC MAINTENANCE PROGRAM

JADE™ RECOMMENDS THE FOLLOWING FOR YOUR INTERIOR CAR CARE. ALL LEATHER/VINYL SURFACES SHOULD BE CLEANED BI-WEEKLY WITH A LEATHER CLEANER, OR PH NEUTRAL SOAP. TO AVOID CONTAMINANT BUILD UP. REPLENISH THE LEATHERS NATURAL OILS WITH A LEATHER CONDITIONER. VACUUM CARPETS REGULARLY AND USE A CARPET CLEANER FOR SPILLS AND MESS WHEN NECESSARY. WIPE SPILLS IMMEDIATELY ON ALL INTERIOR SURFACES INCLUDING VINYL, LEATHER OR FABRIC.

## ANNUAL INSPECTIONS

JADE™ HIGHLY RECOMMENDS ANNUAL INSPECTIONS OF THE CERAMIC COATING. THIS ENSURES THAT THE COATING IS MAINTAINED AND CARED FOR PROPERLY. ANNUAL INSPECTION SHOULD BE PERFORMED BY A JADE™ CERAMIC CERTIFIED INSTALLER WITHIN 30 DAYS BEFORE THE ANNIVERSARY DATE OF THE LAST SERVICE TO ENSURE THE COATINGS PERFORMANCE. JADE™ CERAMIC COATINGS ARE EXCEPTIONALLY DURABLE AND LONG LASTING, AND WITH ANNUAL INSPECTIONS THIS WILL ENSURE THE COATINGS GLOSS WILL KEEP PERFORMING.

#### JADE™/PURIS WARRANTY PRODUCTS:

- I. JADE™ WARRANTY TERM BEGINS FROM THE DATE OF REGISTRATION OF THE WARRANTY AT IADE-CFRAMIC COM
- THIS AGREEMENT EXCLUDES VEHICLES USED FOR COMMERCIAL PURPOSES AT ANY TIME BEFORE, PRESENTLY OR DURING THE WARRANTY PERIOD.
- 3. INITIAL APPLICATION MUST BE PREFORMED BY A CERTIFIED JADE™ CERAMIC INSTALLER.
- 4. ANY APPLICATION, REAPPLICATION, REPAIR WORK, OR OTHER WORK CARRIED OUT ON THE COATED SURFACE MUST BE APPLIED, REAPPLIED, OR REPAIRED BY A CERTIFIED JADE™ CERAMIC INSTALLER AFTER CLAIM APPROVAL BY JADE™.
- A JADE™ REPRESENTATIVE MUST BE NOTIFIED OF ANY CLAIM DUE TO FAILURE OF PRODUCT PERFORMANCE WITHIN 10 DAYS OF INCIDENT OCCURRENCE.
- 6. VEHICLES OVER 3 MONTHS OLD REQUIRE A MACHINE POLISH PERFORMED BY AN APPROVED APPLICATOR OR JADE™ CERAMIC COATING CERTIFIED INSTALLER PRIOR TO APPLICATION. NEWER VEHICLES MAY ALSO REQUIRE A MACHINE POLISH IF ADVISED BY THE JADE™ CERAMIC COATING CERTIFIED INSTALLER.
- 7. VEHICLE MUST REMAIN CONTINUOUSLY REGISTERED WITHIN NORTH AMERICA FOR THE DURATION OF THE WARRANTY, AND WARRANTY WILL REQUIRE THE ORIGINAL VEHICLE OWNER'S NAME TO REMAIN ON THE REGISTRATION. WARRANTY CANNOT BE TRANSFERRED TO A NEW OWNER.

#### JADE™ EXTERIOR PAINT WARRANTY AND PERIOD OF COVERAGE

#### JADE™ 7 YEAR

WARRANTY IS VALID FOR 7 YEARS FROM THE DATE OF APPLICATION FOR ANY VEHICLE. THIS WARRANTY REQUIRES ANNUAL INSPECTIONS AND BECOMES A I-YEAR WARRANTY FROM THE LAST INSPECTION DATE IF AN INSPECTION IS MISSED.

## JADE™ 5 YEAR

WARRANTY IS VALID FOR 5 YEARS FROM THE DATE OF APPLICATION FOR ANY VEHICLE. THIS WARRANTY REQUIRES ANNUAL INSPECTIONS AND BECOMES A I-YEAR WARRANTY FROM THE LAST INSPECTION DATE IF AN INSPECTION IS MISSED.

#### JADE™ 3 YEAR

WARRANTY IS VALID FOR 3 YEARS FROM THE DATE OF APPLICATION FOR ANY VEHICLE. THIS WARRANTY REQUIRES ANNUAL INSPECTIONS AND BECOMES A INVALID FROM THE LAST INSPECTION DATE IF AN INSPECTION IS MISSED.

#### JADE™ GENERAL LIABILITY LIMITATIONS

JADE™ OR ITS REPRESENTATIVES SHALL NOT ACCEPT LIABILITY FOR THE FOLLOWING:

- WORKMANSHIP ERRORS AND FAULTY WORKMANSHIP, SUCH AS BUT NOT LIMITED TO, HIGH SPOTS, STREAKS, AND LOW SPOTS NOT COVERED.
- DETERIORATION OF FACTORY INSTALLED EQUIPMENT OR ANY OTHER TREATED PART OF SUBSTANDARD SPECIFICATIONS, MATERIALS OR WORKMANSHIP BY VEHICLES MANUFACTURER, THEIR DEALERSHIP, THIRD-PARTY SUPPLIER OR MODIFIER. OR PROFESSIONAL DETAILERS NOT CERTIFIED BY JADE™.
- 3. SWIRL MARKS, MARRING, SCRATCHES, SCUFFS, SCRAPES, CHIPS TO THE PAINTED SURFACE, HARD WATER SPOTS, PRE-EXISTING DAMAGE OR DETERIORATION; AND/OR ANY CLAIM FOR MATTERS WHICH ARE COVERED BY VEHICLE MANUFACTURERS WARRANTY.
- 4. DAMAGE CAUSED BY MANUAL OR AUTOMATIC WASH BRUSHES, CONTAMINATED AND/OR ABRASIVE CLOTHS AND SPONGES, UNTREATED AREAS DUE TO ACCIDENT DAMAGE AND/OR THEIR SUBSEQUENT REPAIRS, AND/OR DAMAGE CAUSED BY IMPACT WITH A FOREIGN OBJECT (IE. ROCK CHIPS AND BUG MARRING)
- 5. WARRANTY IS VALID FOR FACTORY CLEAR COATED SYSTEMS ONLY AND EXCLUDES ANY NON-CLEAR COATED OR MATTE FINISHES.

### JADE™ EXCLUSIONS

JADE™ WARRANTY FOR ANY PRODUCT WILL BE CONSIDERED INVALID IF ANY OF THE FOLLOWING GENERAL CONDITION OCCUR:

- I. NEGLECT TO MAINTAIN THE VEHICLE BY THE OWNER ACCORDING TO THE STANDARDS AND TECHNIQUES RECOMMENDED BY JADE™. FAILURE TO MAINTAIN DUE CARE OF THE TREATED SURFACE RESULTS IN WARRANTY VOID
- 2. DAMAGE CAUSED BY ABRASIVE COMPOUNDS. POLISHES AND THIRD-PARTY PRODUCTS.
- 3. DAMAGE RESULTING FROM A COLLISION OR OTHER VEHICLE ACCIDENTS
- 4. DAMAGE OR STRUCTURAL FAILURE OCCURS AS THE RESULT OF RACING APPLICATIONS OR WILLFUL ABUSE.
- 5. DAMAGE, EITHER ACCIDENTAL OR MALICIOUS, INCLUDING BUT N<mark>OT LIMITED</mark> TO FIRE, F<mark>LOOD, EXTREME WEATHER</mark> CONDITIONS, SECONDARY EFFECTS THAT MAY RESULT FROM THE FOREGOING, OR ANY OTHER FORCE OF NATURE.
- 6. MANY AREAS OF THE COUNTRY USE ROAD SALTS AND CHEMICALS DURING THE WINTER MONTHS THAT CAN CAUSE ADVERSE EFFECTS ON YOUR VEHICLE AND WHEELS, IT IS RECOMMENDED TO CLEAN MORE FREQUENTLY DURING THIS SEASON. FAILURE TO DO SO MAY GREATLY REDUCE THE LIFE OF THE PRODUCT.
- 7. FAILURE TO REPAIR AND RE-TREAT SURFACES SUBJECT TO ACCIDENT DAMAGE IN ACCORDANCE WITH THE WARRANTY.
- 8. DAMAGE CAUSED BY ANY ALTERATION OR MODIFICATION TO THE VEHICLE SURFACES.
- 9. DAMAGE CAUSED BY MANUFACTURER'S DEFECTS.

#### ANNUAL INSPECTION

- I. ANNUAL INSPECTIONS MUST BE CARRIED OUT BY AN APPROVED APPLICATOR/INSTALLER, WITHIN 30 DAYS BEFORE THE ANNIVERSARY DATE OF THE LAST SERVICE TO MAINTAIN THE WARRANTY.
- 2. FAILURE TO UNDERTAKE AN ANNUAL INSPECTION WITHIN THE REQUIRED. WILL CHANGE THE PERIOD OF COVERAGE TO THE MINIMUM NUMBER OF YEARS STATED IN EACH DIFFERENT WARRANTY IN PART OF THIS WARRANTY DOCUMENT.

#### JADE™ WARRANTY VALIDITY

THE WARRANTY IS VALID FOR ONE (I) YEAR FROM THE DATE OF APPLICATION FOR ANY CAR. JADE™ WARRANTS TO THE OWNER OF THE NOMINATED VEHICLE THAT THE TREATED SURFACES WILL REMAIN FREE OF PERMANENT STAINS AND UV DAMAGE, EXCEPT AS OTHERWISE NOTED IN THE WARRANTY.

JADE™ OR ITS AGENTS SHALL NOT ACCEPT LIABILITY FOR THE FOLLOWING:

I.
